Regarding the Ministry of Public Health announced that the coronavirus disease 2019 or COVID-19 is a dangerous communicable disease and currently spreading rapidly in many countries around the world. (The details of the Proxy form A-C shall be enclosed in the invitation letter)

2. Company will provide the screening of the participant(s) by taking the temperature together with observing to indicating the participant(s) that is in fever or respiratory symptoms before attending the meeting and provide handwashing point or alcohol gel in front of the meeting room. Company recommends shareholders to wear a hygienic mask during the meeting to reduce the spread of various diseases in the respiratory system. In the event that the participant(s) has a fever (body temperature 37.5 degrees Celsius or more) or suspected symptoms, Company reserves the right to not allow the participant(s) attending the meeting. Shareholders are still able to exercise the right to vote by grant a
